Diploma of Building and Construction (Building)

Course Overview:

This is a trade qualification delivered through online training of building professionals who apply knowledge of structural principles, risk and financial management, estimating, preparing and administering building and construction contracts, selecting contractors, overseeing the work and its quality and managing construction work in building projects including residential and commercial with the following limitations:

- Residential construction limited to National Construction Code Class 1 and 10 buildings to a maximum of 3 storeys.
- Commercial construction limited to National Construction Code Class 2 to 9 buildings, Type C and B construction.

Academic Requirement: Completion of Year 12 VCE or equivalent overseas qualifications. Additionally, having a strong interest in the building and construction industry and possessing adequate literacy and numeracy skills are important.

Course Entry Requirements: All students must be 18 years of age to apply. Successful completion of the Application form and Language Literacy and Numeracy (LLN) Test administered by Northwood International College along with Pre-Training review is in place to determine the suitability of the qualification and specific learning style. Applicants must be at least 18 years old at course commencement. International students must meet English language requirements through one of the following: IELTS score of 5.5 or equivalent; IELTS 5.0 with 10 weeks of ELICOS; IELTS 4.5 with 20 weeks of ELICOS; Pearson PTE Academic score of 42; Cambridge CAE; TOEFL paper-based score of 46–59; CELS Upper Intermediate certificate; completion of Year 12, Certificate IV or higher in Australia; or tertiary studies in English.

Additional Requirement: Northwood International College (NIC) conducts a Language, Literacy, Numeracy and Digital Literacy (LLND) assessment during orientation to gauge each student's skill levels and determine the level of support needed for timely completion of the qualification; this assessment is diagnostic only and does not restrict course entry. Additionally, students must obtain a construction induction (white) card before undertaking any site visits. Personal Protective Equipment (PPE) is required when visiting a construction site. (Steel cap boots, Hard hat, High Vis and Glasses)

Mode of Delivery: Face to Face Classroom, Workshop sessions
